On full repayment of the 1st loan, maximum loan amount will be ₹20,000/- in the 2nd cycle, and after full repayment of 2nd loan; maximum loan amount will be ₹50,000/- in the 3rd cycle. For the purpose of 2nd and 3rd loan, my application will be auto generated after full repayment of previous loan and sent to the lender. I will become eligible for the next cycle of the loan only after full repayment of earlier loan and submission of consent either digitally or manually for the subsequent loans.

I have no objection to authenticate my Aadhaar number, share the same with other Ministries / Departments under the Government of India or the State Government for the purpose of extension of benefits under any of their Schemes, carry out e-KYC and accessing my credit history & credit score from credit bureau by the lenders and their authorized agents.
